## 1. CONTENTS OF THE SERVICE

## 2. OPENING THE SERVICE

To access Tax Gold, select 'butterworths services' from the Butterworths Lexis Direct home page (single click) and then left click 'Tax Services', pictured below.



The next screen you see will be the Tax Services page. From this page select either Tax Direct News or Tax Direct Libraries, depending on which one you are subscribed to.

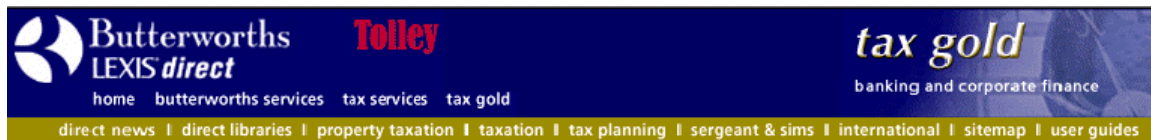

To return to Tax Gold, simply left click 'tax gold', at the top-right of the bar once.

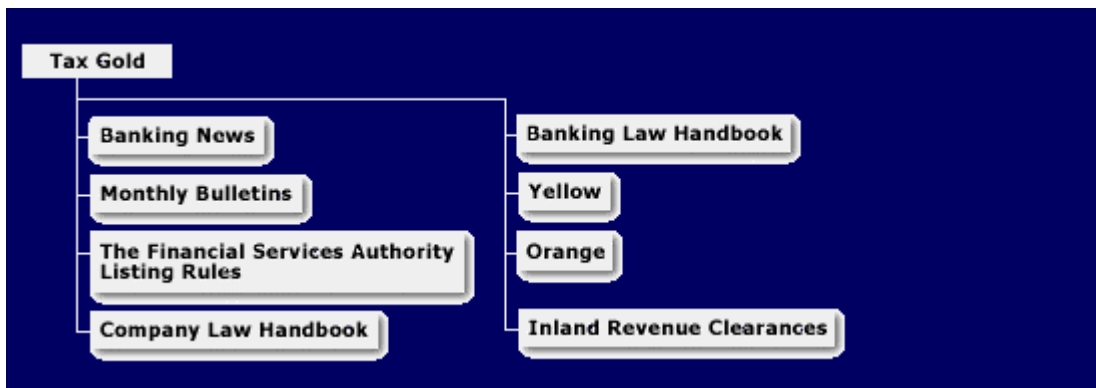
#### 3.2 BOOKS ON SCREEN [BOS]
